Purchase Agreement

I (We) promise to pay each invoice in full within (30) days of the date of invoice, or as specified in terms and conditions of a separate written contract. If, however, this account is not paid as agreed, a delinquency charge shall accrue on the amount of the unpaid balance at the end of the month following the date of invoice. The delinquency charge shall be computed at the rate of 18% per annum on the unpaid balance or at the highest rate of interest allowed by applicable law, for loans or forbearance of money, whichever is less; provided, said charge shall be computed at a rate not less than 12% per annum. We agree to give written notice to Motors and Controls Corporation prior to the sale or transfer of all or substantially all of the stock or assets of our business; if we fail to do so, then we shall remain fully liable for any unpaid merchandise received by the buyer or transferee of the business. If this account is placed in the hands of a licensed collection agency, I (We) then agree to pay you an amount equal to the amount charged you on said collection by such collection agency, not exceeding, however (35%) of the amount unpaid thereon, together with such reasonable attorney fees as may be incurred in connection with the collection. Motors and Controls Corporation may place venue in the Superior Court of King or Pierce County, Washington and the prevailing party shall be awarded its taxable costs.

This agreement is governed by State of Washington law, without regard to conflict of laws.
